"Declaration Affidavit as a Texian National of the Republic of Texas Nation"

Sec. 1. *Be it resolved*, I now affirm that my word is my bond and I declare the following: I will not intentionally harm another living man/woman soul and I respect all other living men/women's private property (ies). I now reserve my entire God-given unalienable rights, waiving none, and I shall forever stand under the God of Abraham, Isaac and Jacob, and God's Natural Law, which encompasses all Nations on His earth and the Republic of Texas Nation Common Law.

Sec. 2. *Be it resolved*, I now declare that the following facts are true, correct and complete, are my own first-hand knowledge, and I have no disabilities that would prevent me from making this declaration. I further declare, me, myself and I that I am responsible for all my actions, affairs and public conduct.

Sec. 3. *Be it resolved*, I now affirm as having been an inhabitant domiciled for a minimum of six months on the lands with the Republic of Texas' boundaries as confirmed within several organic International Treaties. I now claim to be by affidavit a Texian National of the Republic of Texas Nation who lives in God-given liberty, conducting my private affairs without any government or corporate intervention. I am not wanted, or under indictment for any crime on the lands of the Republic of Texas Nation or any other foreign entity under Common Law and my declaration is made without deception or for evasion purposes.

Sec. 4. *Be it resolved*, I now affirm under International Law to claim my full voting rights in the Republic of Texas Nation as my priority Country with full knowledge that International Law disallows any individual to have voting rights in two or more separate Countries.

Sec. 5. *Be it resolved*, I now affirm that my word is my bond and with my Declaration Affidavit as a Texian National of the Republic of Texas Nation, I declare my complete support and defense for my entire Republic of Texas Nation's lands, waters, and airspace. With geographical boundaries that are signed and sealed within several organic International Treaties. I further proclaim that I stand on God's Natural Law and the jurisdiction of the Republic of Texas Nation. I further stand on the documents of the organic foundation of the Republic of Texas Nation; those partly being the 1836 Declaration of Independence, reservation of my entire 1836 Declaration of Rights being sealed, signed, and attached to the organic 1836 Constitution of which was amended, and "Voted by ballot and passed September 5th, 2007 by the Texian people.

Sec. 6. *Be it resolved*, the Republic of Texas Oaths and Affirmations are always the Superior Oaths and Affirmations above all other affiliations. In the event, evidence comes to light of any/all such affiliations, said Texian National of the Republic of Texas Nation, shall be removed immediately and shall not affiliate with Republic of Texas Nation government officials. *Article I. Sec. 14.*

Sec. 7. *Be it resolved*, I disclose below any/all affiliations I have affirmed, taken, or sworn any oath, pledge, promise, to any group, society, association, guild, foreign government, three letter agencies, etc., any/all violent criminals, violent affiliations, violent societies and secret societies that may be in conflict with the constitutional oaths and affirmations of the Republic of Texas, and would be intent on harming the Texian people. And any other affiliations outside of the Republic of Texas, contracts as a private contractor or employment with any corporate government entities, prior elected positions, prior groups associated with the de facto parties, or any other groups or corporations who have participated in fraud, and when you renounced those affiliations. I hereby have renounced and disclosed all affiliations under the penalty of perjury below. (Add Additional pages if needed). Those affiliations that do not appear to be in conflict should still be listed below for transparency. In the event there is a conflict, I agree that I will denounce said affiliation. Include all names, participation, and time frames for both types of affiliations.

Sec. 8. *Be it resolved*, I now acknowledge that all applications are subject to review and approval by the Secretary of State of the Republic of Texas Nation. If the applicant is approved after full due diligence of a background check, the Texian National will be notified of the application approval.

Sec. 9. *Be it resolved*, I now affirm that I am a sovereign living man/woman and the undersigned sui juris (*) Texian National of the Republic of Texas Nation:
